Section 2 - MTA Training Grant

The MTA's Education and Development Committee administers charitable grants on behalf of The MTA Education Trust (Charity Number: 1081690). The MTA will pay 50% of any training course you wish to participate in, to upskill your workforce up to a maximum of £750 (i.e. if course costs £1500 MTA will pay £750).

Note that the £750 limit applies to MTA members who pay a membership fee equal to or more than £1500. For members who pay less than £1500 then the maximum training grant will be half of the membership fee.

This grant cannot be used for compliance/mandatory training (i.e. GDPR etc).

Associate and Honorary MTA members are not eligible for MTA Training Grants.
